(i) On 4 July 2014 the Company entered into an Escrow Deed arrangement with its then current employees, consultants and the former CEO, covering potential liabilities arising from i) Notice entitlements, ii) Termination payments and where applicable, iii) Retention payments, for an aggregate amount of A\$3.6 million. The Company deposited these funds into a bank account under the administration of an escrow agent in accordance with the terms of the Escrow Deed. A significant portion of these liabilities had been met through to 30 June 2015 with the balance of funds held by the escrow agent at 31 December 2015 of A\$0.2 million (30 June 2015 A\$0.3 million). Pursuant to the terms of the Escrow Deed the balance of funds held by the escrow agent of A\$0.2 million were returned to the Company in early January 2016.


